

## Terms & Conditions of Sale To Matic Distributors and Account Holders

Payment Terms – Strictly net 30 days where arranged. We reserve the right to withhold goods on overdue accounts. Ownership of the property and goods shall remain with Matic Furniture Pty Ltd until payment has been received in full.

Prices – Ruling price is the price at which goods are invoiced. Prices are subject to change without notice. Prices quoted do not include G.S.T. The governing rate of G.S.T. will be added to all invoices.

Freight – Orders will be delivered within the Sydney region via road and at the sellers' discretion. Any other method or area will be at customers' expense.

Claims – Claims will be considered if Matic Furniture Pty Ltd is notified of the claim within 7 days of receipt of the goods.

Returns – Returns for credit will only be considered when the item is not in accordance with the original order and no more than 7 days have elapsed since its receipt. Please contact our head office for information regarding the procedure for return.

Cancellation of order— A cancellation can only be considered if the goods have not been ordered from our suppliers.

Goods on Hold – Goods can only be held for 7 days and will be released for delivery after that time.

Interest – May be charged at 1.75% per month on overdue accounts.

Contingencies – No liability shall result on Matic Furniture Pty Ltd caused by circumstances beyond the control of Matic Furniture Pty Ltd.

Warranties – Matic Furniture Pty Ltd warrants that the goods supplied are fit for the purpose for which they are designed only and that the goods are not covered by any other warranty if the goods are used in any other way. Refer to individual product warranty period as listed on pricelist or web as all products do vary, with a minimum 1 year from purchase date unless otherwise stated (subject to terms outlined in this Notice). Warranty includes all goods located on the Australian mainland. Matic do not cover warranties on goods that have been distributed and transported outside of the Australian mainland.

Accounts – Partial or full accounts are charged at the time of despatch and will be paid accordingly.

Approved account customers will adhere to the above terms and conditions of sale. Those conditions will also apply to non approved customers who will have paid a deposit of 50% to obtain those goods and have agreed to pay, in the Sydney region, the balance of the account on a C.O.D. basis. Those customers outside the Sydney region will come to a special arrangement with Matic Furniture Pty Ltd regarding the payment of their accounts.

Selection of colour – Whilst every endeavour will be made by Matic Furniture Pty Ltd to match existing or perceived colours it cannot be guaranteed since changes of fabric, the light and the colour itself may change at our supplier's discretion.

Inspection of goods – Please check all goods upon delivery and inform Matic Furniture Pty Ltd of any variation from your order or your invoice, no consideration will be made after 7 days have elapsed from receipt of goods.

Samples – Samples are supplied with the expressed wish to only indicate the style of the products and not the exact nature of the goods.

Limitation of Liability – Matic Furniture Pty Ltd shall only be required to repair, replace or to credit the costs of the goods deemed to be faulty and accepts no liability for other costs involved.
